On Teens, Youths, and S.O.'s:
Can/Should we ask the teens (who are not the Village's Teen Crew), to do one or more workparties? How about directing them to Youth Power to help get their jobs done?
Q: How many teen passes did we have last year? A: 39 teens, 14 youth (11 & 12-yr-olds) (plus 5 or 6 more at the sticker booth). Bulldogs: So many bulldogs are little kids (very young).

Corollary observation: Don't seem to be any incidents where those kids can't get the help they need. Teen Crew... Suggestion to have SO's do at least the same as teens. Teen Crew has been coordinated by Diane for quite a while now. 3 booths get an allocation, and the work shifts, get a pass, and SO clarification: one meeting plus one work party and idea that every wristband should be doing a sweep or two.
