

RESTAURANT SELECTION PROCESS COMMITTEE NOTES & PROPOSALS

We hope the Village can reach consensus on the first proposal at the April General Meeting so the new committee may begin working by August/September.

PROPOSAL 1: Restaurant Selection Committee Structure and Duties

The Restaurant Selection Committee (RSC) will consist of no more than 8 CV members, one of whom is the current council liaison to the Restaurant. If more than 7 want to be on the committee then names will be drawn randomly from a hat. Members of the committee may not be affiliated with any of the applicants nor cast a public recommendation. The RSC will review applications, attend the OCF tasting, and present recommendations and opinions to the village for a decision at the April 2012 meeting. The RSC will conduct the post-Fair Restaurant Evaluation at the September 2012 CV General Meeting. Thereafter, a new RSC will be appointed in April of each restaurant evaluation year.

Section 2

Candidates' Presentation to Village

INFORMATION ONLY / NO DECISION REQUESTED:

The committee in conjunction with the OCF Food Committee will select the top three applicants, if there are three QUALIFIED applicants, to bring forward to the village for a decision.

If possible, the top candidates will participate in a general village tasting, for a \$2 sampler plate per candidate, \$6 total per person (if all applicants agree; price is negotiable and meant to be affordable) before the March/April meeting. Each booth will be asked to send at least one or two representatives. Tasting will be open to all villagers by reservation. The top applicants will bring food as if they were catering an event.....

At the March or April general meeting (2012),

- the Restaurant Selection Committee will explain why they recommend these top 3 choices based upon food, business & village scoring
- people who attended the sampler plate tasting give testimonials, pro & con (meaning the Restaurant Committee is not the sole palate)
- Villagers ask questions of the applicants, or tasters...

Restaurant Selection Decision ---- PROPOSAL #2

- Agree that consensus is suspended for the restaurant selection decision because taste is subjective (note a precedent was set the last time we selected a new restaurant)
- Decision is open to villagers who have participated in the village in one of the last three Fairs, age 14 and older, excluding anyone affiliated (owner, staff, family) with the restaurant. Markers will be distributed through Booth Coordinators.
- The top candidates are listed on different posters. During Booth Breakdown, each eligible participant places their marker on their preferred choice.
- The RSC tallies the marks and the candidate with the most markers

is the selected restaurant.

* This decision will be made at the March or April meeting Note -- this is the same process used the last time the restaurant was opened with changes to who may participate....

March/April new restaurant decision at general village meeting August 2012 Restaurant Committee prepares evaluation forms ready by Teddy Bear Picnic for hardcopy and on-line versions. Evaluation forms submitted to committee by the last Friday in August. Committee reviews evaluation forms, drafts summary, and makes recommendation at the September general meeting.

The committee is still working on this section; it is not ready for a proposal. We would appreciate your thoughts. Join the discussion.

Questions we're asking the OCF Food Committee:

Does OCF check in withbooths to verify they meet Fair criteria? How do you put someone on noitice, what follow-up sanctions? Do they do an evaluation? How often are you willing to play?

Our question to the village:

at what point do we ask to open up the restaurant again? What is in the villages' best interest... Or should we automatically renew after every third year's positive eval?

Contract - an unfinished proposal

The new restaurant will be evaluated in September. The evaluation will be organized by the Selection Committee and Council Restaurant liaisons. If the evaluation is positive, the restaurant's contract is automatically renewed for 3 years. At end of the 4th year, a newly appointed RSC will conduct another evaluation. If the evaluation is good then the contract is automatically renewed for another 3 years.

This committee thinks, based upon positive evaluations, the restaurant may have the booth a minimum of 7 years before full-on opening is reasonable.

Evaluation Criteria RSC will create a form based upon taste, service, presentation, relative pricing, health & safety, good village member, good fair member, anything else we should know? RSC will review evaluations and present recommendation to village at September general meeting. Evaluation forms will be available at the August Teddy Bear Picnic and/or on-line. Summary will be presented to the current restaurant prior to the September meeting so they may respond to feedback.

Council is compiling these results and will bring them to the meeting in May
